- 1) This approval is granted on the basis of the relevant test reports no. 054ASPE/2007 dated on 23rd November, 2006 issued by Lucidus-Optical Measurements and IBR/Z-021-2006 dated on 6th March, 2006 issued by Szczecin University of Technology and 43/2004 dated on 28th April, 2006 & 252/2009 dated on 13th August, 2009 issued by The institute of Technical Textiles "MORATEX".
- 2) Installation of the tape is to be carried out in accordance with the Manufacturer's instruction.
- 3) The Mareflex MF-01 AntiSpray Tape cannot be used for pipes insulation or as replacement for pipe gaskets and sealings.
- 4) The extent of use is limited to spray shielding applications on oil pressure pipes located above the floor plates and which have no insulation in way of the joints.
- 5) Use is restricted to easily accessible positions where the integrity of the application may be inspected regularly and new covering applied after removal for maintenance purposes.
- 6) Individual product certification is not required.
